### **Support Civil War Preservation Act 2007**

The Civil War Preservation Act of 2007 reauthorizes the Civil War Battlefield Preservation Program. This program provides Federal matching grants that have saved over 14,000 acres of battlefields.

Our ancestors fought on some of these battlefields to include Champion Hill, Perryville and Franklin.

You can help secure future funding by contacting your Representative and Senators. Legislators won't cosponsor a bill unless they hear from their constituents. If HR 2933 and S 1921 pass, funding will be secured through 2013.

### **CSI Knoxville 1863**

Gary Goodson sends information from his contacts in Knoxville concerning a surveying course at the University of Tennessee. The students in a class called CSI Knoxville 1863 used ground penetrating radar and metal detectors to investigate the mass grave at Bethel Cemetery where 1,600 Confederate soldiers are buried. Bethel Cemetery was a tour stop during our Second Congress in 2003.

The mass grave was known but the edges and what might be in the mass grave were not known.

This is interesting, but the reason it is important to us is that they may need a new area to practice their skills in the future. Maybe the lead professor can be interested in doing a "CSI Knoxville 1862" at Camp Van Dorn. Gary has found the camp and graves are believed to be in the area so maybe the students can map the graves and locate previously unknown graves.

### **Harris Griggs Project**

Speaking of projects, Harris Griggs has volunteered his time and effort to produce a product from our files. Currently, ancestor information is safely filed, by year, in our files. Since 2002 there has accumulated quite a stack of New Member Profiles, in various forms, which contain information on the ancestors which we remember and honor.

This information will be extracted and put into a spreadsheet which can then be printed or sent to interested members. Some of the details supplied by the families are not found in other sources. For example: "Wounded in left hip at Resaca". Another fact that comes out is that the families had many members in other units as well as our five regiments. Some of the families knew each other as they came from the same area.

The overall idea is to take interesting information that is in our files and get it out to the members. Once developed it can be added to as more information comes in.

There is no time table for the completion of this project but it is hoped to be ready at least by Marietta 2008 Congress.

### **Outreach Effort**

I have been thinking that we should attempt to make an Outreach Effort when we have a Congress in a certain area.

The idea would be to let other interested groups know about us and what we do. Perhaps we can find other descendants or interested parties if they knew what we were doing.

“They” would be organizations such as SCV, UDC, local historical societies, and groups like the Civil War Roundtable and Friends of Civil War Paulding County. I am sure there are others that you know about in your area.

After bouncing this idea off Kay Borden, who will be a presenter at next year’s Congress in Marietta, a trial effort has been launched. The Friends of Civil War Paulding County has a newsletter and they announced that they were looking for items to put into their newsletter. Kay worked up a news release about our association and how it will meet next Labor Day Weekend and that we will see battlefields in Paulding County. Some companies of the 40th Georgia and 41st Georgia came from Paulding County. This announcement was accepted and it will be sent out soon.

If this development gives you ideas among your contact list, please let me know. We could get a like message out to that group too. This effort is part of “networking” or what I call expanding your web of contacts. An example of the value of this is : Our member, Dr. David Wiggins , knew two local experts who could be our guides in the Marietta area. Through his contacts I was able to make rapid contact and start developing the details of who will be assisting us next year.

### **Nominations and Elections**

During the Sixth Congress at Danville, Kentucky we were able to develop a slate of nominations for the officers and historians for the next three year period. One of the nominees had not confirmed if he would accept the nomination. Since that time, I have not received any additional nominations.

I have asked Founder and Historian Emeritus Gary Goodson if he would conduct the actual election. He has accepted this task and will receive the votes and count the votes. In a number of cases there is only one person running for the office, so the count will be a formality.
